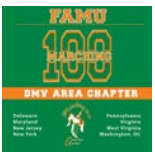

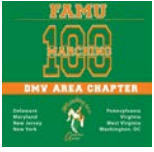

9. New Business

The focus of next month's meeting, 19 May 21, will be on FAMU 'recruitment' in terms of the existing requirements for acceptance into FAMU as well as the requirements for participation in the FAMU Band Program.

Kim offered to make flyers for the event, and it was suggested that the event be held on a weeknight as opposed to our regular Saturday afternoon timeslot.

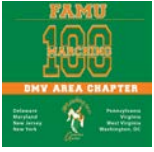

We will start our regular meeting for May at 6:30PM, PRIOR TO the recruitment event, and we will hold participants in the waitingroom until we are ready to begin.

Kim also offered to allow us access to her Zoom account so that we do not have any issues with a potential large number of participants logging in for the recruitment meeting.

Andrea will reach out to Dr. Chipman to find out if he, Mr. Baker, or a designee can join the call to make a 5-10 presentation that gives an overview about the Marching 100 and FAMU bands. After which Larry and Andrea will commence with the recruitment presentation that was distributed by FAMU's Office of Admissions and Recruitment. We will ask that whoever joins us from the FAMU Band program remain on the Zoom event and answer any questions that pop up in the chat.

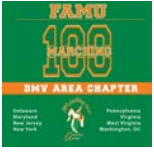

Andrea and Larry will be reaching out to high school band directors via email to share the flyer and encourage them to share information about the event with their band students.

10. **Announcements:**

- a) 'Minding Our Business' Campaign. Our DMV Area Chapter is still Encouraging alumni & associate members to participate in this chapter initiative whereas M100 alumni & associate members can advertise their particular business or businesses on our DMV Area Chapter website. During this period of the COVID-19 Pandemic, we hope & trust that these advertised businesses will get exposure to many potential customers.
