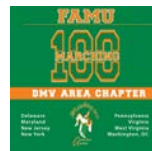

Meeting Minutes

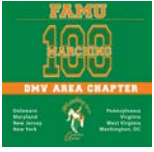

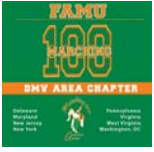

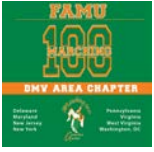
